

CBAM REGISTRATION GUIDE FOR NON-EU OPERATORS

One Pager Overview

WHAT IS THIS FOR?

Non-EU operators can submit installations and emissions data via the **CBAM O3CI Portal**

STEP 1: Create EU Login Account

1. Go to <https://webgate.ec.europa.eu/cas>
2. Register with email (*company email strongly recommended*), create password, confirm via email link.
3. Set up 2-Factor Authentication (EU Login App, QR code, or FIDO2 key) - See **page 12** of our [guidance document](#) for more information
4. Each user must register individually.

1. Go to <https://cbam.ec.europa.eu/o3cinstallation>
 - Log in using your EU Login credentials.
 - Complete the onboarding form with:
 - Company details and registration number/identifiers
 - Company email and website
 - - User role: Admin Operator or Simple Operator
 - - Upload a single PDF containing (We strongly recommend submitting your documents in English, such as a courtesy translation, along with the original documents):
 - * Company registration certificate (include the company registration number/relevant identifier, ensuring it matches the identifier provided in the onboarding form)
 - * Proof of representation (e.g., power of attorney)
 - * ID of the authorized representative

STEP 2: Submit Access Request (Onboarding Wizard)

Example identifiers (not to be used in your request):

- IN123456ABCD (IN for the 2-letter country-code for India, followed by some letters and numbers)
- BR.XYZ-1234567890 (BR for the 2-letter country-code for Brazil, followed by a separator (dot), followed by other characters.

We recommend using the following identifiers for the countries listed below:

- **For China:** Unified Social Credit (USC) number
- **For India:** Corporate Identification Number (CIN) or Limited Liability Partnership Identification Number (LLPIN)
- **For the United Kingdom:** Company Registration Number (CRN)
- **For the United States:** Central Index Key (CIK)
- **For South Korea:** Business registration number (TIN)
- **For Turkey:** Vergi Kimlik Numarasi
- **For Ukraine:** Registration number (EDRPOU)
- **For others:** Business or trade register number, tax identification number, or Legal Entity Identifier (LEI)

STEP 3: **Await Approval**

- Review and submit access request.
- Monitor email address linked to the EU Login account for confirmation and next steps from the Commission.
- *Please note that the approval process may take several weeks*

- Keep data accurate and up to date.
- Use only authorized EU Login accounts.
